



Rules and Regulations of society

3. Membership : Ordinary

Category of members : General

Admission fee Rs. - monthly fee Rs. 10/-  
Annual subscription Rs.

4. General Body : Annual General Body will meet once in a year ie., in the month of January.

II) Functions :

- i. to pass the budget for the ensuing year and approval the expenditure statement of previous year.
- ii. to approve the report of the activities of the society.
- iii. to elect the executive committee etc.
- iv. to appoint an auditor.

5.I. Exact number of the executive committee ( 5 ) ie., President, Vice President, General Secretary, Joint Secretary, Treasurer and remaining persons are executive members.


5.I.A. "The members of the executive committee (Governing Body) shall be duty-bound to attest the signatures of all the meetings of the newly elected executive committee (Governing Body) and to see that the said signatures of an shape of an annual list as filed with the registrar of societies before the 15th day of the succeeding month of the month in which elections were held.

III) FUNCTIONS OF THE EXECUTIVE BODY AND OFFICE BEARERS,

1. PRESIDENT: He presides over all the meetings of the both General Body and Executive Committee. He can caste his vote in the position. He can supervise all the branches of the society.

2. VICE PRESIDENT: He shall assist the President in discharging his duties. In the absence of the President he will perform the duty of the President as entrusted by him.

SECRETARY: He is the Chief Executive Officer of the society and custodian to all records relating to the society. He has to convene both the bodies of the society with the permission of the president. He guide the Treasurer in preparing the budget and expenditure statement of the society to put before the general body of its approval.

4. JOINT SECRETARY: He has to do the work as entrusted by the executive committee. He has to assist the secretary in discharging his duties. In the absence of the President/Secretary he can perform the duty of the Secretary.

5. TREASURER: He is the responsible person of all the financial transactions relating to the society and he has to maintain accounts properly alongwith the vouchers. He has to prepare the budget and expenditure statement of the society with the guidance of the secretary. He has to prepare the budget of the society jointly with the secretary or president.

6. OFFICE BEARERS: They are the responsible persons to doing the activities of the club which the executive committee entrusted to them.


7. QUORUM: Half of the total members for general body meeting and 1/4th for executive committee meeting.

8. FUNDS: The funds shall be spent only to the attainment of the objects of the society and no portion thereof shall be paid or transferred directly or indirectly to any of the members through any means.

9. AMENDMENTS: No amendment or alteration shall be made in purpose of the association unless it is voted by 2/3rd of its members present at a special meeting convened for the purpose and confirmed by 2/3rd of the members present at a second special meeting.

10. WINDING UP: In case the society has to be woundup the property and funds of the society that shall be transferred or paid to some other insitutution with similar aims and objects.





